Guest hereby assumes the risk of any and all personal injury and /or damages to or loss of personal property that occurs during the course of their visit at PMC. Guest assumes such risk even if the injury or damage is caused by the negligence of others, including but not limited to PMC employees, officers, directors, agents, vendors or anyone else on PMC's property.

**RELEASE & INDEMNITY:**

In consideration for being permitted to visit and observe PMC operations, Guest, their spouse, heirs, personal representatives or assigns do hereby release PMC, its principals, directors, officers, agents, employees, and each and every land owner upon whose property PMC's operations are conducted from all liability; and waive any claim for damage arising from any cause whatsoever, including negligence, wrongful acts, omissions, breach of liability, breach of warranty or strict tort liability. Guest hereby agrees to indemnify and hold PMC harmless from any claims, demands, or causes of action which are related to Guest's visit to PMC.
